What is this product?

Type I Undertaking for Collective Investment in Transferable Securities - Société d'Investissement à Capital Variable (SICAV), incorporated in France.

Term I The life of the product is 99 years. This term may be extended or the Fund can be dissolved early on the initiative of its Board of Directors. The terms and conditions for extension or dissolution are described in more detail in the articles of association of the SICAV.

Objectives | ECHIQUIER ARTY SRI is a subfund whose objective is performance over the recommended investment period through a discretionary and opportunistic investment strategy on the interest rate and equity markets with a composite benchmark: 25% MSCI Europe Net Return, 25% compounded €STER, 50% Iboxx Euro Corporate 3-5 years. The manager of the subfund selects among the issuers in the investment universe those considered to have an attractive risk/return combination.

The composite index 25% MSCI Europe Net Return, 25% Compounded €STER, 50% iBoxx Euro Corporate 3-5 years may be a representative indicator for the management of ECHIQUIER ARTY SRI.

The UCITS implements active and discretionary management based on bond picking for fixed income and stock picking for securities. The subfund invests between 0% and 50% of its net assets in equities, primarily mid-caps and large caps, in any business sector (companies with a capitalisation of less than €1 billion are limited to 10%). Investments will be made mainly in European equities (European Union, European Free Trade Association and United Kingdom), but with the possibility of investing up to 15% of its net assets in equities from countries outside this region, including in emerging market equities. For fixed-income products, the minimum exposure of the UCITS to bonds or negotiable debt securities is 40% of its assets. At the time of acquisition and for monitoring purposes over the life of the securities, credit risk is assessed on the basis of in-house research and analysis by La Financière de l'Echiquier and using the ratings produced by agencies. The portion of securities deemed speculative, known as high-yield securities (rating below BBB -) or considered as such by the management team or unrated, may not exceed 10% of net assets for negotiable debt securities or 15% of net assets for bond securities. The subfund may also invest up to 40% of its net assets in subordinated bonds of the banking, insurance and corporate sector, including 10% maximum of contingent convertible bonds (so-called "coco" bonds). The issuers of fixed-income products will be mostly European (EU, EFTA and the United Kingdom).

Securities are chosen in two stages:

1.First step: Analysis of the investment universe

The investment universe consists of the securities making up the following indices:

Markit iBoxx Euro Corporates (50%) + Markit iBoxx EUR Liquid High (in euros) (20%) + Stoxx Europe Total Market net dividends reinvested (in euros) (30%).

It is analysed using socially responsible investment (SRI) criteria, in order to identify the companies with the best practices in terms of sustainable development. This analysis is based on a proprietary tool of the LBP AM group for the extra-financial rating of issuers: GrEAT, and on the other hand on the application of exclusions.

The analysis of the universe presented above enables to determine, after elimination of 25% of the securities from the investment universe, the average SRI rating that the UCI must exceed (the "Average Enhanced Rating"). The UCI must obtain a better average SRI rating than the Average Enhanced Rating. The Average Enhanced

Rating is the average SRI rating of the adjusted investment universe, i.e. after elimination of the 25% worst securities (including the two following filters: quantitative score and exclusions).

Therefore, all securities in the investment universe (excluding prohibited and excluded securities) are therefore eligible for the UCI, provided that the UCI's average extrafinancial rating complies with the above condition.

 Second step: Selection of securities according to their financial and extrafinancial characteristics:

Following this first step, the manager carries out a fundamental analysis of each issuer based on the following criteria:

- -Analysis of the company's management
- Quality of its financial structure
- Visibility on future earnings
- Analysis of the financial results
- The growth prospects for its business
- The speculative nature of the share
- The UCITS may trade in derivatives to:

-Reduce the portfolio's exposure to equity markets, foreign exchange and interest rate risks.

-Exceptionally expose the portfolio to currency, interest rate and equity risks. The UCITS does not, in any event, intend to implement a strategy of over-exposing the portfolio to these various risks.

Allocation of distributable amounts I Accumulation

Subscription/redemption procedures I Subscription and redemption orders are centralised daily at 12:00 p.m. and executed at the net asset value calculated on the basis of the day's closing market prices. The net asset value is calculated daily with the exception of French public holidays and/or days on which the French markets are closed (official calendar of Euronext Paris S.A.) Investors with access to the IZNES shared electronic registration system may send their subscription and redemption orders to IZNES.

Targeted retail investors I This product is intended in particular for retail investors who (i) have basic knowledge and limited or no experience of investing in UCIs, (ii) want an investment consistent with the investment objective and the recommended holding period of the product, and (iii) are prepared to assume a low level of risk on their initial capital. What are the risks and what could I get in return?



The synthetic risk indicator makes it possible to assess the level of risk of this product compared to other products. It indicates the likelihood that the product will incur losses in the event of market movements or if we are unable to pay you.

We have classified this product in risk class 2 out of 7, which is a low risk class. In other words, the potential losses linked to the product's future results are low and, should the situation deteriorate on the markets, it is unlikely that our ability to pay you will be affected.

The synthetic risk indicator is based on the assumption that you hold the shares for the whole recommended investment period of five years.

The other materially relevant risks not taken into account in the calculation of the product's SRI are as follows:

- Credit risk
- Liquidity risk
- Counterparty risk

Unfavourable scenario: this type of scenario occurred for an investment in the product between 30/09/2021 and 30/09/2022 (1-year scenario) and between 30/09/2017 and 30/09/2022 (5-year scenario)

What happens if La Financière de l'Échiquier is unable to pay out?

The product is incorporated as a separate entity to the Management Company. In the event of failure of the Management Company, the assets of the product held by the depositary will not be affected.

In the case of failure of the depositary, the risk of financial loss for the product is reduced due to the legal segregation of the assets of the depositary and those of the product.

What are the costs?

Costs over time:

The tables show the amounts deducted from your investment in order to cover the different types of costs. They depend on the amount you invest, the time you hold the product, and the product's return.

We assumed:

- that in the first year you will recover the amount you invested (annual return of 0%);
- that for other holding periods, the product changes as indicated in the moderate scenario;
- that EUR 10,000 is invested in the first year.
