**Description:** Carmignac Credit 2027 is a French common fund (Fonds Commun de Placement – FCP), governed by European Directive 2009/65/EC (UCITS) and authorised in France by the Autorité des marchés financiers (AMF) under number FCP20220095.

## WHAT IS THIS PRODUCT?

### TYPE

Carmignac Credit 2027 is a French common fund (Fonds Commun de Placement – FCP), governed by European Directive 2009/65/EC (UCITS)

### TERM

The fund was launched on 02/05/2022 for a period of 99 years, except in the cases of early dissolution or extension.

### OBJECTIVES

The investment objective is to offer performance, net of management fees, from a portfolio made up of securities from public or private sector issuers (including securitisation instruments representing up to 40% of net assets), with no restrictions in terms of average rating, duration, maturity or public/private split. The fund will therefore be exposed to the credit markets as well as the fixed income markets. With no restrictions on average rating, the fund aims for potentially high exposure to high yield debt securities which offer higher potential yields than investment grade debt securities (rated at least BBB or equivalent, or of credit quality deemed equivalent by the portfolio manager), but expose the fund to a higher level of risk (in particular that of issuer default). The portfolio is put together gradually from the fund's inception date until 29 July 2022 and is then intended to be held until a liquidation period beginning six months before the fund matures on 30 June 2027 (buy-and-hold strategy), or until any early maturity date.

- No later than 4 August 2025 if the internal rate of return (IRR) between 30 June 2022 and 30 June 2025 is 2.85% or more, equal to a NAV of EUR 108.80; or
- No later than 4 December 2025 if the IRR between 30 June 2022 and 30 October 2025 is 2.65% or more, equal to a NAV of EUR 109.11; or
- No later than 3 April 2026 if the IRR between 30 June 2022 and 27 February 2026 is 2.49% or more, equal to a NAV of EUR 109.42; or
- No later than 4 August 2026 if the IRR between 30 June 2022 and 30 June 2026 is 2.35% or more, equal to a NAV of EUR 109.74.

The investment strategy consists of creating a diversified portfolio of debt securities and securitisation instruments to be held until the maturity date (or the early maturity date if applicable). The portfolio may be made up of securities of any maturity, including those maturing after the fund's maturity date, with no rating restrictions. While the portfolio thus created is intended to be held until the maturity date, the portfolio manager reserves the right to buy or sell the securities therein, especially if they expect the security's risk profile to deteriorate or identify an investment opportunity in line with the

fund's objective and strategy. In the event that the fund's early maturity conditions are not met, as the maturity date nears, the fund will adopt a prudent management approach during the divestment phase. Securities will be kept until they mature or, especially in the case of securities maturing later than the fund, resold.

The fund may invest up to 110% of its net assets in bonds from the private or public sector, with no restrictions as regards sector or geographic region (up to 40% outside OECD countries, including emerging markets); high yield bonds may account for up to 100% of net assets. The fund may also invest up to 40% of its net assets in securitisation instruments such as collateralised loan obligations (CLO). During the portfolio construction phase, the fund may deviate from the investment limits up to 100% of the net assets for each of these instruments.

Prior to the Maturity Date, or the Early Maturity Date if applicable, and depending on prevailing market conditions, the management company will opt either to continue a similar investment strategy with a new target maturity date, or to merge the fund with another UCITS, or to wind up the fund, subject to AMF approval.

The fund has no reference indicator. The fund is an actively managed UCITS. The investment manager has discretion over the composition of the portfolio, subject to compliance with the investment objective and the investment policy.

### INTENDED RETAIL INVESTOR

Due to the fund's maturity date, this fund is suitable for investors who do not plan to withdraw their money before June 30, 2027, and whose goal is to grow their investment without any capital guarantee.

The appropriate amount to invest in this fund depends on the personal situation of the investor, their knowledge of investment products and experience, their personal wealth, their cash requirements now and in the future, and their degree of risk aversion.

### OTHER INFORMATION

This unit is an accumulation unit.

Investments may be redeemed each business day on request. Subscription and redemption requests are centralised on each NAV calculation and publication day before 13:00 CET and are executed on the next business day using the previous day's NAV.

The Fund's custodian is BNP Paribas, S.A.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator : the summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

Risks not sufficiently considered by the indicator include:

- Counterparty risk: the fund may suffer losses if a counterparty defaults and is unable to meet its contractual obligations, especially in the case of derivatives traded OTC.
- Credit risk: the fund is invested in securities whose credit rating may decline, meaning there is a risk that the issuer may not be able to meet its commitments. Should an issuer's creditworthiness deteriorate, the value of the bonds or derivatives linked to this issuer may fall.
- Liquidity risk: the markets in which the fund participates may be subject to temporary illiquidity. These market distortions could have an impact on the pricing conditions under which the fund may be caused to liquidate, initiate or modify its positions.

## WHAT HAPPENS IF CARMIGNAC GESTION IS UNABLE TO PAY OUT?

The fund is a co-ownership of financial instruments and deposits separate from the management company. In the event of the latter's default, the product's assets held by the depositary will not be affected. In the event of default by the depositary, the risk of financial loss of the product is mitigated due to the legal segregation of the assets of the depositary from those of the fund. There is no compensation or guarantee system in place that would fully or partially offset this loss.

## WHAT ARE THE COSTS?

### HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

The recommended investment period is until the Maturity Date, i.e. 30 June 2027. However, you can redeem your investment without penalty at any time during this period, or hold onto the investment for longer. Redemptions can be made on any business day. In exceptional circumstances, the management company may temporarily restrict redemptions in order to protect investors' interests. For example, a mechanism to cap redemptions (gates) may be triggered when net redemptions exceed 5% of the fund's net assets, resulting in the partial execution of redemption requests and the deferral of the remainder to one or more subsequent net asset value calculation dates. In addition, a swing pricing mechanism has been introduced. Under swing pricing, the net asset value is adjusted when net subscriptions and redemptions reach certain thresholds, so as to cover the cost of rebalancing the portfolio following significant subscriptions/redemptions and thereby protecting the interests of unitholders.
