## WHAT IS THIS PRODUCT?

**Type:** GuardCap Global Equity Fund (the "Fund") is a sub-fund of GuardCap UCITS Funds plc, an investment company with variable capital incorporated in Ireland with registered number 552001, established as an umbrella fund with segregated liability between sub-funds and as an undertaking for collective investment in transferable securities pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended. Segregated liability between sub-funds means that the assets and liabilities of each sub-fund are segregated by law. The prospectus and periodic reports are prepared for GuardCap UCITS Funds plc at umbrella level. You may switch your shares in the Fund to shares in other sub-funds in which you are eligible to invest. Further information is available from CACEIS Bank, Ireland Branch.

**Term:** The Fund has no maturity date. The Management Company is not entitled to terminate the Fund unilaterally nor can the Fund be automatically terminated.

### Objectives:

**Investment Objective:** The investment objective of the Fund is to seek long-term growth of capital with lower than market volatility.

**Investment Approach:** The Fund will invest primarily in shares and related instruments of shares issued by high quality companies and listed in countries which are members of the Organisation of Economic Co-operation and Development ("OECD").

The Fund will invest in companies which it believes show a variety of positive indicators, such as a sustainable competitive advantage over other similar companies, excellent management, a strong financial history and outlook and a proven track record of quality growth.

The Fund may also invest in other asset classes, including, but not limited to, debt securities and interest rates. The Fund may increase its holding in cash and other liquid assets at times of market turbulence. The debt securities in which the Fund invests may be issued by a government or other entity, have a fixed or floating rate of interest and will be rated investment grade.

The Fund will invest in assets which the Investment Manager believes are more likely to achieve its investment objective of long-term growth of capital.

The Fund promotes environmental and social ("E/S") characteristics and invests in companies with good governance (e.g. in terms of management structure and remuneration, high quality reporting). Among other E/S characteristics, the Fund applies certain sectoral exclusions and maps of its portfolio against the United Nations Sustainable Development Goals (SDGs). In light of its investment strategy, the Fund discloses in accordance with Article 8 of the Sustainable Finance Disclosure Regulation. For more details, please refer to the Fund supplement.

**Benchmark Uses:** The Fund is actively managed and its performance may deviate materially from the MSCI World Index (the "Benchmark"). The Investment Manager has complete discretion in making investments and is not constrained by the Benchmark. The Benchmark is used for performance comparisons purposes only. The Investment Manager may consider, for example, sector weights, country weights and tracking error in each case relative to the Benchmark but does not use the Benchmark as an investment limitation.

The Fund may use financial derivative instruments (i.e. instruments whose prices are dependent on or more underlying assets, "FDI"). FDI and assets in which the Fund may invest which embed FDI, may allow the Fund to obtain market exposure in excess of the value of the Fund's assets (leverage).

**Hedging:** The Fund does not intend to engage in currency hedging at the Fund level or at Class level. Accordingly, Classes may have foreign currency exposure to the assets of the Fund that are not denominated in the relevant Class Currency.

Income and capital gains from the Fund are reinvested.

**Intended Retail Investors:** The Fund is suitable for all investors seeking long-term growth of capital with lower than market volatility. The investor should plan to stay invested for at least 10 years and be prepared to bear losses.

**Depositary:** The Fund's assets are held through its depositary, which is CACEIS Bank, Ireland Branch and are segregated from the assets of other sub-funds of GuardCap UCITS Funds plc.

## WHAT HAPPENS IF WAYSTONE MANAGEMENT COMPANY (IE) LIMITED IS UNABLE TO PAY OUT?

To protect you, the assets are held with a separate company, a depositary. Should the Fund default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

## WHAT ARE THE COSTS?

### COSTS OVER TIME

The tables show the amounts that are taken from your investment to cover different types of costs.
