What is this product?

TYPE OF PRODUCT

The product is a sub-fund of BIL Invest, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Sub-Fund is established for an unlimited duration. However, the Board of Directors of the Sub-Fund may decide to close the Sub-Fund under certain circumstances.

OBJECTIVES

Investment policy

The Sub-Fund mainly invests, through other sub-funds and derivatives, in bonds from anywhere in the world, including emerging markets. The Sub-Fund may also invest in other asset classes such as equities, money market instruments, commodity markets and alternative strategies.

Specifically, the Sub-Fund may be fully exposed to equity and equity-related securities. The Sub-Fund may lower this threshold to 25% under unusual market conditions. The Sub-Fund may also invest in, or be exposed to, debt and debt-related securities of any credit quality and money market instruments.

The Sub-Fund may be fully invested in, or be exposed to, UCITS, including ETFs, and other UCIs.

The Sub-Fund may also invest in, or be exposed to, the following, up to the percentage of total net assets indicated:

- deposits with credit institutions: 20%
- UCITS, including other ETFs and other UCIs that are not SFDR article 8 or 9: 15%

Non-EUR investments may be hedged to EUR.

Derivatives and techniques The Sub-Fund may use derivatives for reducing risks (hedging) and costs, and for generating additional income or growth.

The Sub-Fund intends to use core derivatives only.

Investment strategy

In actively managing the Sub-Fund, the investment manager combines macroeconomic, market and fundamental analysis to adjust exposure to asset classes and geographic areas, and to select investments that appear to offer above-average growth prospects, particularly in relation to trends in financial markets.

Sustainability approach The investment manager integrates environmental, social and governance (ESG) criteria factors as a core element of its strategy. In particular, the investment manager assesses potential investments based on both proprietary and third-party ESG scoring methods and, for sub-funds in which it may invest, their exclusion or inclusion policies.

The Sub-Fund adheres to the management company's sustainable investing policy.

The Sub-Fund is classified as article 8 as per the SFDR regulation.

Benchmark The Sub-Fund is not managed in reference to a benchmark.

INTENDED RETAIL INVESTOR

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 5 years.

The return of the product is determined by using the net asset value calculated by the Central administration. This return depends mainly on the market value fluctuations of the underlying investments.

The Sub-Fund's assets are segregated from assets of other sub-funds of the SICAV. The assets of the Sub-Fund cannot be used to pay debts of other sub-funds.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

What happens if WAYSTONE FUND MANAGEMENT (LUX) S.A. is unable to pay out?

There is no guarantee in place against the default of the Fund and you could lose your capital if this happens.

The Fund's assets are held with CACEIS Bank, Luxembourg Branch and are segregated from the assets of other funds of the SICAV. The assets of the Fund cannot be used to pay the debts of other funds.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take my money out early?

Recommended Holding Period (RHP): 5 years.

The RHP was chosen to provide a consistent return less dependent on market fluctuations.

Redemptions are possible each bank business days in Luxembourg. All redemption requests must be received in good order by the Registrar and Transfer Agent prior to 12pm (Central European time) on three (3) bank business days preceding the applicable valuation date. Redemption proceeds shall be paid in the relevant Reference Currency usually one (1) bank business day following the applicable valuation date.
