Objectives and Investment Policy

Investment Objective

The Sub-Fund's investment objective is to seek both income and growth of your investment from an actively managed bond portfolio.

Investment Policy

The Sub-Fund is actively managed without reference to any benchmark. The following investment decisions are undertaken after comprehensive macroeconomic and microeconomic analysis of the market:

- duration positioning (duration measures in numbers of years the portfolio's sensitivity to interest rate variations)
- yield curve positioning (the yield curve illustrates the relation between investment term and bond yield)
- geographical allocation
- issuer selection

The Sub-Fund invests in bonds of any type, including inflation-linked bonds, and any credit quality from issuers anywhere in the world, specifically mainly in investment grade transferable debt securities denominated in EUR and issued by governments, public institutions and companies. The Sub-Fund's average duration is expected to be from -2 to 8 years.

The Sub-Fund may invest up to 20% of its net assets in sub-investment grade securities, which may not be rated CCC+ or below by Standard & Poor's or equivalent rating by Moody's or Fitch or if unrated then deemed to be so by the Investment Manager. In case of downgrade below such minimum securities will be sold within 6 months. If two different ratings of rating agencies exist, the lower rating will be considered, if more than two different ratings of rating agencies exist, the second highest rating will be considered. The Sub-Fund may also invest up to 30% of net assets in subordinated debt securities (including perpetual bonds up to 25%) issued by banks, insurance companies and non-financial corporates, up to 100% of net assets in callable bonds and up to 30% in bonds issued by emerging markets issuers.

The selection of credit instruments is not exclusively and mechanically based on their publicly available credit ratings but also on an internal credit or market risk analysis. The decision to buy or sell assets is also based on other analysis criteria of the Investment Manager.

The Sub-Fund may invest up to 5% of net assets in contingent convertible bonds (CoCos).

The Sub-Fund may invest its net assets in 144A securities, in a substantial way depending on the opportunity.

The Sub-Fund may invest in money market instruments.

Within the limit of 200% of the Sub-Fund's net assets, the investment strategy may be achieved by direct investments and/or through derivatives, especially by entering into Credit Default Swaps. Derivatives may also be used for hedging purposes.

The Sub-Fund is a financial product that promotes environmental and/or social characteristics within the meaning of article 8 of the Regulation (EU) 2019/2088 of 27 November 2019 on sustainability-related disclosures in the financial sector.

Income

For Capitalisation share classes (Cap), the dividend is reinvested.

Sub-Fund Currency

The reference currency of the Sub-Fund is EUR.

Investment Horizon


This Sub-Fund may not be suitable for investors who plan to withdraw their contribution within 3 years.

Processing of subscription and redemption orders

The subscription, conversion or redemption orders must be received by the Registrar and Transfer Agent on any Valuation Day no later than 3 p.m. Luxembourg time. Orders will be processed at the Net Asset Value applicable to such Valuation Day. The investor's attention is drawn to the existence of potential additional processing time due to the possible involvement of intermediaries such as Financial Advisers or distributors.

The Net Asset Value of this Sub-Fund is calculated on a daily basis.

Additional Risks (risks materially relevant to the fund which are not adequately captured by the indicator)

Counterparty Risk: Risk of bankruptcy, insolvency, or payment or delivery

failure of any of the Sub-Fund's counterparties, leading to a payment or delivery default.

Credit Risk: Risk that issuers of debt securities held in the Sub-Fund may default on their obligations or have their credit rating downgraded, resulting in a decrease in the Net Asset Value.

Impact of any techniques such as derivatives: Certain management strategies involve specific risks, such as liquidity risk, credit risk, counterparty risk, legal risk, valuation risk, operational risk and risks related to the underlying assets.

The use of such strategies may also involve leverage, which may increase the effect of market movements on the Sub-Fund and may result in significant risk of losses.

Charges

The charges you pay are used to pay the cost of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.


The entry and exit charges shown are maximum figures. In some cases, you might pay less - you can find this out from your Financial Adviser.

For the different shareclasses of the Sub-Fund, the performance of the benchmark is displayed in the "Past Performance" section either as converted to the currency of the relevant shareclass or hedged against the reference currency of the Sub-fund in the case of hedged shareclasses ("hedged benchmark"). For some cases where the hedged benchmark is not available, the benchmark is displayed in the reference currency of the Sub-Fund, thus the performance of the displayed benchmark may deviate from the one of the relevant shareclass due to the performance differential inherent within the currency hedging activity not reflected in the benchmark. The Fund was previously managed in reference to the 100% FTSE EuroBIG 5-7 Yrs. As of 16 September 2021, the Fund is managed without reference to any benchmark.
