## OBJECTIVES AND INVESTMENT POLICY

### Principal assets traded:

Investment fund pursuing strategies of all types, for example fixed-income securities arbitrage, convertible bond arbitrage, market neutrality, equity hedging, global macro, managed futures.

### Investment strategy:

The fund seeks to achieve capital growth by investing in the principal assets traded over the recommended investment period.

Within the limits of the fund's investment objective and policy, the management team makes discretionary investment choices in the portfolio based on its analyses of the characteristics and growth prospects of the assets traded. The fund seeks to combine the pursued strategies in a suitable way. To boost yield, these alternative funds may engage in short buying and selling and/or use very high leverage on occasion.

The fund's principal objective is to achieve controlled volatility and decorrelation from the traditional markets.

The fund partly or fully hedges the risk linked to USD in EUR by means of swaps, foreign exchange contracts, options, etc. For

more information on the strategies used and the diversification criteria, please refer to the prospectus.

The Fund does not have a sustainable investment objective and does not specifically promote environmental and/or social characteristics.

This share class aims to reduce the effect of fluctuations in exchange rates between the reference currency of the sub-fund EUR and the USD (the currency in which the share class is denominated). This reduces the foreign exchange risk but does not eliminate it entirely.

The fund may use derivative products both for investment and hedging purposes (hedging against unfavourable future financial events).

**Redemption of shares:** On request, once a month, in Luxembourg.

**Allocation of income:** Reinvestment.

**Recommendation:** This fund may not be suitable for investors who plan to withdraw their capital within 3 years.

## RISK AND REWARD PROFILE

**The investor needs to be aware of the following significant risks which are not necessarily adequately taken into account by the indicator:**

• **Arbitrage risk:** The fund may use the technique consisting in taking advantage of price differences (recorded or anticipated) between two securities/sectors/markets/currencies. If such arbitrage transactions perform unfavourably (a rise in selling transactions and/or fall in buying transactions), the net asset value of the fund may fall.

• **Credit risk:** the fund is exposed to the risk of default of an issuer in terms of honouring the payment of coupons and/or the repayment of the amount borrowed. This risk is higher as the fund may invest in high-yield debt issues whose issuers are considered risky.

• **Counterparty risk:** The fund may use OTC derivative products and these may represent a counterparty risk, i.e. the inability of the counterparty to honour its commitments to the fund. This counterparty risk could be fully or partially hedged by the receipt of guarantees.

• **Risk related to financial derivative instruments:** their use implies risk associated with the underlying assets and can accentuate downward movements via the resulting leverage effect. Hedging strategies using derivatives may not be perfect. Some derivatives may be difficult to value under exceptional markets circumstances.

• **Emerging countries risk:** emerging countries may experience political, legal or fiscal uncertainties or other events that could impact negatively on the assets of the fund. The assets traded in these countries may be subject to market movements that are potentially more rapid than in the major international markets and listing differentials that may be considerably bigger under certain market conditions. These assets may prove to be less liquid and may not be able to be sold quickly and at reasonable prices. Exchange rate fluctuations involving the currencies of emerging countries may be sudden and substantial.

• **High leverage risk:** the use of potentially high leverage may result in significant volatility, and the fund may suffer increased losses depending on this level of leverage.

• **Liquidity risk:** the fund invests in financial instruments and/or market segments that are considered as having little liquidity. Sometimes these instruments take a long time to sell or may have restrictions on their sale. This risk is accentuated in certain market circumstances and/or in case of large-scale redemptions and this can affect the fund's performance.

• **Model risk:** the securities making up the portfolio of the funds are selected essentially on the basis of quantitative models. There is a risk that these models are less efficient, or that they may even present deficiencies, under certain specific market conditions.

• **Sustainability risk:** refers to any event or situation in the environmental, social or governance domain that could affect the performance and/or the reputation of the issuers in the portfolio. The sustainability risk may be specific to the issuer, depending on its activities and practices, but it may also be due to external factors.

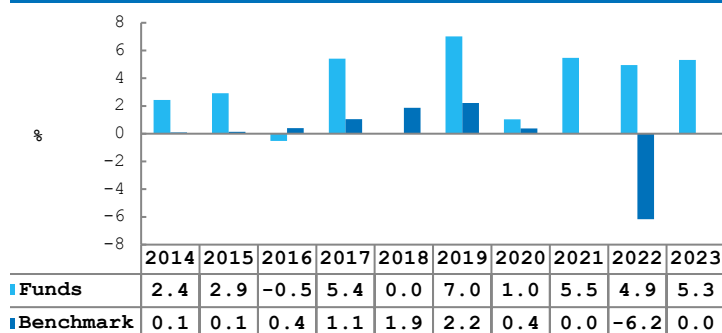
### Ongoing charges:
