What is this product?

Issuers that do not meet the Triodos sustainability standards are excluded from investment. It compares its returns with the MSCI World Index, which it does not aim to replicate or outperform. The fund may deviate from the benchmark because it only invests in companies that meet strict sustainability criteria.
