Objectives and Investment Policy

The Fund is classified as a financial product under Article 8 of the EU Sustainable Finance Disclosure Regulation. The Fund promotes environmental or social characteristics but does not have a sustainable investment objective. The Fund integrates ESG factors and risk in the investment process alongside traditional factors. The fund invests in debt instruments (i.e. notes, bonds, certificates, derivatives, etc) issued and/or denominated in the currencies of low or middle-income developing countries ("emerging markets") in Latin America, Asia, Central Europe, Eastern Europe and Africa. In most cases, the remaining life of these instruments is less than one year. Furthermore, the fund enters in emerging market currency forward contracts (a currency market transaction in which a seller agrees to deliver a specific currency to a buyer at some point in the future). The fund may also invest in Chinese onshore debt securities through Bond Connect, a market facilitating investment to the Chinese bond market. Measured over a period of several years we aim to beat the performance of the benchmark 75% J.P. Morgan Emerging Local

Plus (ELMI+) EUR (hedged), 25% J.P. Morgan Emerging Local Markets Plus (ELMI+). The benchmark is a broad representation of the investment universe. We actively manage the fund via currency allocation, curve positioning and instrument selection. The portfolio is diversified across countries and instruments. The portfolio composition can significantly deviate from the benchmark. For this specific hedged share class we apply a currency hedging strategy. By hedging our currencies we aim to avoid currency risks for euro investors against the base currency of the sub-fund (USD). We hedge the implicit US dollar currency exposure of the reference benchmark, JP Morgan Emerging Local Markets Index Plus (ELMI+), of the sub-fund to the reference currency of this share class (EUR). When calculating this implicit exposure we take into account our estimates of correlations between currencies. The risk of exchange rate fluctuations of implicit non-US dollar exposure against the EUR remains in this share class. A currency hedge consists of taking an offsetting position in a related currency through a forward contract. You can sell your participation in this fund on each (working) day on which the value of the units is calculated, which for this fund occurs daily. The fund does not aim to provide you with a dividend. It will reinvest all earnings.

Charges


The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
