### Objectives and investment policy

The Fund seeks to grow capital and generate income by investing in high-yield instruments, complemented by an allocation to sovereign and quasi-sovereign debt securities denominated in USD.

The Fund will maintain a nominal net exposure of between 80% and 120% to High Yield instruments via the use of CDS indices (Credit Default Swap) within the framework of effective portfolio management.

The Fund is actively managed and at any time, it can invest a majority of its net assets in bonds and other debt securities.

A minimum of 50% of the sovereign bond investments will be in issuers deemed to maintain environmental (E) and social (S) characteristics with a minimum Environmental, Social and Governance (ESG) rating of BBB for developed market issuers and BB for emerging market issuers as measured by MSCI ESG research or equivalent data providers or if such rating is not available an equivalent internal rating assigned by the Investment Manager. The derivative exposure implemented by the Fund to gain exposure to the High Yield market falls out of the scope of the ESG strategy. ESG investment strategy is based on three pillars applying to sovereign bonds: (i) Sector exclusion according to the UBP Responsible Investment policy; (ii) ESG integration to select issuers through an internal quantitative scoring system and a qualitative ESG check; (iii) a preference for Green bonds.

The Fund is not managed in reference to a benchmark.

High yield bonds are issued by entities whose activity is more sensitive to the economic cycle and pay higher interest. The return on such securities, in the same way as their level of risk, is therefore higher than traditional bond products.

Exposure to high yield bonds is implemented via cleared and diversified high yield CDS indices. CDS indices offer a liquid exposure to high yield and bear minimal interest rate risk.

The Fund's base currency is USD.

The share currency risk in relation to the Fund's base currency is mainly hedged.


Any income received by the Fund is reinvested (capitalisation share class).

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive markets are closed: United States (US), United Kingdom (UK).

### Risk and reward profile

**Credit risk:** The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. 
