What is this product?

Type

The product is a UCITS - Part 1 sub-fund of a SICAV under Luxembourg law.

Term

This product is an open-ended fund without predefined maturity. This product may be redeemed early under certain circumstances that are described in more detail in the sales prospectus. For information regarding redemption options and the frequency of redemptions, please refer to the section entitled "How long should I hold it and can I take money out early". The LC share class of DWS Invest Multi Opportunities was launched in 2014.

Objectives

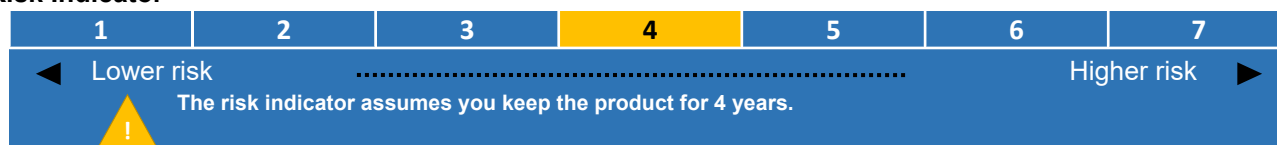
The fund is actively managed. The fund is not managed in reference to a benchmark. The fund promotes environmental and social characteristics and is subject to the disclosure requirements of a financial product in accordance with article 8(1) of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector. More ESG information is available in the sales prospectus and on the DWS website. The investment objective of the fund is to achieve capital appreciation. The fund aims to achieve its objective by using an investment approach across international capital markets without benchmark constraints. The fund may invest globally in equities, debt securities, certificates on, for example, equities, bonds and indices, in investment funds, derivatives, convertible and warrant-linked bonds, warrants, participation and dividend-right certificates, money market instruments and deposits with credit institutions. Up to 49% of net assets may be invested in non-investment-grade debt securities. Up to 5% may be invested in distressed debt securities and up to 10% in unrated debt securities. At least 51% of the fund's net assets are invested in assets that comply with the promoted environmental and social characteristics. Within the limits set out in the prospectus, the fund may also use other permitted instrument types or exposures, such as securitisation instruments, hybrid securities, commodities and emerging markets. The fund may invest more than 10% of its net assets in shares of UCITS and/or other UCIs. The fund may use derivatives for investment strategy purposes, for efficient portfolio management and/or for hedging purposes. The fund intends to use securities financing transactions to the extent described in the prospectus. The return of the product is reflected by the daily calculated net asset value per unit and the distribution amount if applicable. The currency of the fund is EUR. Returns and gains are not distributed but are reinvested in the fund. This fund is a sub-fund of DWS Invest for which the sales prospectus and the periodic reports are prepared as a whole. The assets and liabilities of each sub-fund are segregated by law. As a result, assets of one sub-fund are not available in the event of claims against or insolvency of another. More share classes may be available for this fund - please refer to the relevant section of the sales prospectus for further details. Shares may in many cases be exchanged for shares in another share class of the same or another DWS Invest SICAV sub-fund. Details can be found in the "Conversion of shares" section of the sales prospectus. The depositary is State Street Bank International GmbH, Luxembourg Branch. Intended retail investor

The sub-fund is intended for medium term retail investors with basic knowledge/experience, who can bear losses. The sub-fund can be used for general capital accumulation.

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity to pay you.

What happens if DWS Investment S.A. is unable to pay out?

The assets of the fund are kept separately from those of the management company, DWS Investment S.A.. An insolvency or default of the management company should not result in the fund suffering any financial loss in relation to its assets. On the insolvency or default of the depositary State Street Bank International GmbH, Luxembourg Branch securities held by the depositary on behalf of the fund should be protected but the fund may suffer loss in relation to cash and certain other assets which are not protected. Cash deposits of the fund deposited with other credit institutions may cause investors to suffer a financial loss if such deposits are not covered by any existing deposit guarantee schemes. Investment in the fund is not covered by any investor compensation or guarantee scheme.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed: In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario. 10.000 EUR is invested.

*This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 3.9% before costs and 1.3% after costs.

How long should I hold it and can I take money out early?

Recommended holding period: 4 years. The product has no minimum holding period.

This product has no required minimum holding period. The recommended holding period has been selected due to its investment strategy and because it is designed for a medium term investment horizon. It is expected that it will be possible to achieve the investment objective of the fund within this time frame. You may request the redemption of shares generally on each valuation date. No fees or penalties will be charged by the company for any such transaction.

There is no change on the risk return profile when you redeem your shares early.

The asset management company may suspend the issue and redemption of shares if exceptional circumstances mean this appears necessary taking into account the investors' interests. The asset management company may use the following methods to manage liquidity risks: It may restrict redemption if the investors' redemption requests reach a previously defined threshold as of which the redemption requests can no longer be executed in the interests of all investors. By using swing pricing, it may apportion the costs arising from redemptions (e.g., transaction costs) to the investors whose orders caused the trades, thus reducing the risk of dilution for the fund's remaining investors.
