# What is this product?

Type
This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

The objective of the sub-fund is to achieve both capital growth and stable income over the medium and long term, while following an asset allocation allowing managers to flexibly adjust (0% to 100% of the net assets) the weighting of the various asset classes (equities, bonds, money market securities) of the sub-fund, either through direct investments or through the use of derivatives with a view to achieving the desired portfolio allocation.

With the aim of international diversification and risk distribution, the sub-fund may invest its assets directly and/or indirectly through UCIs/UCITS and/or derivatives (e.g. futures):

- up to 80% of the net assets in equities and/or securities equivalent to equities, the majority of which are large capitalisation, admitted for trading on the main world stock exchanges, especially in OECD countries;
- up to 100% of the net assets in transferable bond securities, securities equivalent to bonds, mainly investment grade, and denominated in currencies of OECD countries;
- on an ancillary basis and within the limits provided for by the investment restrictions, as described in Chapter III.1 of the prospectus "INVESTMENT RESTRICTIONS FOR NON-MONETARY SUB-FUNDS", in warrants on transferable securities, in money market instruments or term deposits.

A minority share of the assets (up to 33% of net assets) may include securities of issuers domiciled and/or listed in emerging countries, as well as UCIs/UCITS and/or other instruments authorised under point III.1.A)1.1. of the prospectus with an emphasis on "emerging markets".

For the purpose of good management and/or hedging, the sub-fund may also use all of the derivative financial instruments (for example, currency forwards, futures, options, etc.) and other techniques/instruments set out in point III.1.B

of the prospectus - "DERIVATIVE FINANCIAL INSTRUMENTS AND OTHER TECHNIQUES/INSTRUMENTS", in Chapter III of the prospectus - INVEST-MENT RESTRICTIONS", within the limits provided for.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

The sub-fund is particularly suitable for an investor with a balanced profile looking to participate in the stability of the bond markets, but also in the performance of the stock markets. The sub-fund is suitable both for individual investors looking to invest in the bond and equity markets and for sophisticated investors looking to achieve their investment objectives. The fund is particularly suitable for medium and long term investments, as capital losses may occur due to market fluctuations.

### Other information

Depositary: Banque et Caisse d'Epargne de l'Etat, Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

Additional information: Additional information about the fund, copies of its prospectus, the latest annual and semi-annual report and the latest prices of shares may be obtained free of charge from the management company or on am.lu. The prospectus and the periodic reports are prepared for the entire fund and are available in French. # What are the risks and what could I get in return?

### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

# What happens if Spuerkeess Asset Management S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque et Caisse d'Epargne de l'Etat, Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

# What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. # Recommended holding period: 5 years
