WHAT IS THIS PRODUCT?

Type: Undertaking for Collective Investment in Transferable Securities (UCITS) under European Directive 2009/65/EC. An investment company with variable capital (société d'investissement à capital variable or "SICAV") under Luxembourg law.

Term: This product is not subject to any fixed term.

Objectives: The objective of the Sub-Fund is to provide a regular, above average income through investing in a range of fixed income and fixed income related instruments of issuers worldwide that meet strict criteria ethically and financially. The Sub-Fund is actively managed at the Investment Manager's discretion without reference to any benchmark. The Sub-Fund will gain, directly or indirectly, exposure to investment grade fixed income and fixed income related instruments of sovereign and corporate issuers worldwide denominated in any freely convertible currency. The predominant part of the fixed income and fixed income related securities to which the Sub-Fund will be exposed will be denominated in GBP. There is no guarantee that this investment objective will be achieved over five years, or any other time period.

Intended Retail Investor: This product targets Retail and Professional investors and as a minimum requirement, is suited to a first time investor with a basic knowledge of investments. This product targets investors who intend to invest their money for a minimum period of 5 years. Rathbones defines the minimum recommended holding period of 5 years as Long Term. This product has no capital guarantee and investors may not get back the original amount invested. This product is appropriate for investors who have a risk appetite compatible with the SRI of the product as defined below. This product may be distributed as follows: on an execution only basis without a suitability assessment; with investment advice; or, as a component of a managed portfolio.

The depositary is HSBC Continental Europe, Luxembourg. COSTS OVER TIME
