## WHAT IS THIS PRODUCT?

### Type

Pictet TR - Sirius is a Fund of an open-ended investment company with variable capital ("SICAV") with segregated liability between Funds and is authorised as an Undertaking for Collective Investment Transferable Securities ("UCITS") in Luxembourg.

### Term

This product has no maturity date. The Fund is formed for an indefinite period. However, the Board of Directors may in certain cases decide to close the Fund or at any time propose to close the Fund at an extraordinary general Shareholders' meeting. Dividend distribution policy: Accumulated. You may redeem your investment upon demand. Dealing frequency: Daily. It is also a hedged share class, which means that it is designed to reduce, but not cancel out, the currency risk between the Fund currency and the Share Class currency.

### Objectives

To increase the value of your investment, while seeking a positive return in any market conditions (absolute return) and capital preservation.

### Reference Index

Secured Overnight Financing Rate (SOFR) is used for performance measurement.

### Portfolio Assets

The Fund will seek exposure mainly to emerging markets (including Mainland China) through a broad range of corporate and government bonds, convertible bonds, money market instruments, currencies and/or deposits. These bonds may include Sharia-compliant bonds. The Fund may invest directly in these asset classes or through structured products or derivatives. The Fund can invest across any sector, credit quality and currency.

### Derivatives and Structured Products

The Fund may use derivatives to reduce various risks (hedging) and for efficient portfolio management, and may use derivatives and structured products to gain exposure to portfolio assets.

### Fund Currency

### Investment Process

In actively managing the Fund, the Investment Manager uses market and issuer analysis to select securities that it believes offer favourable growth prospects at a reasonable price (long position) while selling securities of companies that seem to be overvalued (short position). The Investment Manager may invest in issuers with any environmental, social, and governance (ESG) profile. It methodically exercises voting rights and may engage with issuers in order to positively influence ESG practices. The portfolio composition is not constrained relative to the benchmark, so the similarity of the Fund's performance to that of the benchmark may vary.

### Intended retail investor

Suitable for investors with at least average levels of knowledge and/or experience, seeking capital preservation, capital growth, and who have an investment horizon between 3 and 5 years. The product does not have any capital guarantee and up to 100% of their capital is at risk.

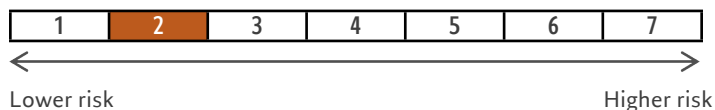

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Risk Indicator

### WHAT HAPPENS IF PICTET ASSET MANAGEMENT (EUROPE) S.A. IS UNABLE TO PAY OUT?

Pictet Asset Management (Europe) S.A. is a société anonyme. The SICAV is also a société anonyme and its assets are segregated from those of the Management Company. The SICAV has entrusted the Depositary Bank with the safekeeping of its assets, which are kept separated from the Depositary Bank's assets. A default of Pictet Asset Management (Europe) S.A. will therefore have no impact on the value of your investment in the product. However, you may benefit from a consumer protection scheme.

### WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

#### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario

- EUR 10,000 is invested.

### HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 3 years.

We have selected this Recommended holding period considering the volatility of the asset class. You can disinvest according to SICAV prospectus without penalty. Refer to the "What are the costs?" section for the impact of the costs on your investment return when you exit.

In certain circumstances, including exceptional market conditions, the fund may apply anti-dilution tools and implement liquidity management measures affecting investors' ability to subscribe or redeem, in order to protect investors and ensure fair treatment, as further described in the prospectus.
