Objectives and Investment Policy

Investment Policy

The Fund invests in an actively and professional managed portfolio of listed companies worldwide which are open to shareholder engagement and integrate environmental, social and governance (ESG) criteria into their strategy.

Investments can take place in all possible sectors.

The Fund may invest directly in equities, liquidities and deposits. The Fund may also invest indirectly by investing in other investment funds. Financial derivates instruments such as options, warrants and futures may be used for hedging purposes and for efficient portfolio management.

The Fund is actively managed and may hold investments that are not included in the benchmark. The investment manager is allowed to deviate significantly

from the benchmark. The benchmark is the MSCI World Total Return Net Index.

Objectives

The Fund primarily aims to generate a long-term return in excess of the benchmark, comprising capital gains or losses plus net dividend.

The Fund falls under the scope of article 8 of the SFDR which means that the Fund promotes environmental and/or social characteristics. While it does not have as its objective a sustainable investment, it will have a minimum proportion of the benchmark level of sustainable investments. The Fund considers principle adverse impact on sustainability factors.

This share class of the Fund does not distribute dividend.

The Fund is not listed at any stock exchange. Shares in the Fund can normally be bought or sold on any business day in Luxembourg.

The Fund is a UCITS fund.

There are various risks with potential impact on the Fund performance which are not fully captured by the risk-reward indicator.

Currency risk

The Fund may invest in assets denominated in other currencies than the Euro. Fluctuations in the exchange rates may affect the value of the investments of the Fund.

What does the indicator mean?

The risk indicator is a measure of the risk which you run when you invest in the Fund. The indicator is based on the volatility of the share price of the Fund over the last five years. The volatility means to which extent the price has risen and fallen. As a general rule, you have to run greater risk to potentially achieve a higher return. Note that a classification in the first category does not mean that you do not run any risk.

Why is this fund in category 6?

The Fund primarily invests in equities that are in general more volatile than bonds and money market instruments. The risk is therefore higher.

Attention:

The indicator is based on historical data over the past five years.

The 'ongoing costs' consist of a management and service fee and a taxe d'abonnement. If there are also investments in other investment companies this percentage also comprises the ongoing costs of those investment companies. Performance fees and transaction costs are not included, unless it concerns entry and exit charges that were paid by the Fund when participations in another investment company were purchased or sold.
