What is this product?

Type: The Fund is a sub-fund of BlackRock Global Funds, an umbrella company incorporated in Luxembourg, authorised by the Commission de Surveillance du Secteur Financier as a Undertaking for Collective Investment in Transferable Securities ("UCITS").

Term: The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objectives

- The Fund aims to maximise the return on your investment through a combination of capital growth and income on the Fund's assets.
- The Fund invests at least 70% of its total assets in the equity securities (e.g. shares) of companies globally whose predominant economic activity comprises the research, development, production and/or distribution of future transport technology.
- The Fund will take into account environment, social and governance criteria when selecting investments as disclosed in the prospectus. For further details please refer to the prospectus.
- The IA may use financial derivative instruments (FDIs) (i.e. investments the prices of which are based on one or more underlying assets) for
 investment purposes in order to achieve the investment objective of the Fund, and/or to reduce risk within the Fund's portfolio, reduce
 investment costs and generate additional income. The Fund may, via FDIs, generate varying amounts of market leverage (i.e. where the
 Fund gains market exposure in excess of the value of its assets). Any ESG rating or analysis referenced above will apply only to the

- The Fund is actively managed. The IA has discretion to select the Fund's investments and is not constrained by any benchmark in this

 described in the prospectus. The weighted average ESG rating of the Fund will be higher than the ESG rating of the MSCI ACWI after
 eliminating at least 20% of the least well-rated securities from the index.
