What is this product?

Туре

This product is a share in a sub-fund of the investment company with variable capital ESTATE ALLIANCE, an undertaking for collective investment in transferable securities (UCITS) under Luxembourg law.

Term

This sub-fund has no maturity date. However, the board of directors of the fund may decide to close the sub-fund under certain circumstances.

Objectives

The objective of the sub-fund is to generate return and capital appreciation in the long term by investing mainly in equity instruments.

The sub-fund mainly invests in investment funds including Exchange Traded Funds (ETF) investing in equities, bonds, money market instruments and/or liquidities. The equity exposure of the investments represents at least 50% of the sub-fund net assets. The investments are not subject to geographical, sectorial of monetary limitations.

The Investment manager's investment policy relies on a monthly Investment Committee that defines the asset allocation within the portfolio, taking into account different aspects as the stocks and bonds markets and the geopolitical and macroeconomic environment. The Portfolio is then implemented into well recognized financial instruments (as UCITS Funds, ETFs or stocks/bonds guoted on recognized markets as Euronext or the New-York Stock Exchange). Every financial instrument has been through a strict Due Diligence process (quantitative and qualitative).

The sub-fund may also invest up to 25% of its net assets in:

- Direct stocks / shares of companies or holdings quoted in a regulated market of the OECD countries, with specific focus on European and United States markets.

- Investment funds including Exchange Traded Funds (ETF) with other investment strategies, including but not limited to long-short strategies and/or real estate.

- Exchange Traded Commodities (ETC) on precious metals provided that such products do not contain embedded derivatives and do not give rise to a physical delivery of the underlying metal. The sub-fund may in a minor sense (up to 15%) invest in regulated

The sub-fund may in a minor sense (up to 15%) invest in regulated UCITS Funds (or ETFs), managed by well recognized companies, with a main focus on Chinese markets.

The sub-fund may, use financial derivative instruments for efficient

portfolio management and hedging purposes.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This product is designed for investors who are willing to achieve income and capital growth and have a medium to long term horizon. The investor can bear losses up to the invested amount. This product is appropriate for investors with a basic to advanced knowledge and experience of the product and the markets.

Dividend income: This class is a capitalisation class meaning that income is reinvested.



Performance scenarios

To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors.
