# What is this product?

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

## **Objectives**

The sub-fund invests a minimum of 75% of its assets in equities and equities related securities issued by companies worldwide. In accordance with section 2 § 6 German Investment Tax Act ("GITA"), the sub-fund shall continuously invest at least directly 51% of its net asset value (i.e. predominantly) in shares of corporations which are listed on a stock exchange or traded on an organized market.

The remaining 25% of the assets will be invested in bonds, warrants on bonds and other debt instruments issued by domestic or foreign borrowers.

The sub-fund may use all types of financial derivative instruments for hedging and investment purposes.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

### Intended retail investor

This product is designed for investors who are willing to achieve income and capital growth and have a medium to long term horizon. The investor can bear losses up to the invested amount. This product is appropriate for investors with

a basic to advanced knowledge and experience of the product and the global equity markets.

### Other information

Depositary: Banque de Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

# What are the risks and what could I get in return?

#### Risk indicator

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

# What happens if STRATEGIC SELECTION FUND is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

# What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

#### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible ínvestment periods.

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
