You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type: Shares in Nomura Global Equity Compounders Fund (the "Sub-Fund"), being a compartment of Nomura Fund Solutions, a Luxembourg incorporated investment company with variable capital qualifying as Undertaking for Collective Investment in Transferable Securities (UCITS).

Term: The share of the Sub-Fund is issued in registered form. The Sub-Fund does not have a fixed maturity date and is established for an unlimited duration though it may also be dissolved by compulsory redemption upon a decision of the Directors (i) if its Net Asset Value has decreased below the minimum holding deemed appropriate for its existence in the interest of the Shareholders, or (ii) if a change in its economical or political situation would have material adverse consequences for its investments, or (iii) in order to proceed to an economic rationalisation.

Objective: The Sub-Fund aims to provide Shareholders with a long-term capital appreciation by investing broadly and globally in publicly listed shares. The objective of the Sub-Fund is to create a portfolio with a healthy balance of quality and valuation characteristics with the aim to maximize the risk adjusted return potential.

Portfolio Securities: The Sub-Fund will aim to meet the investment objective by primarily investing in publicly listed shares from what the Investment Manager considers as quality companies and at attractive valuations. The Investment Manager seeks to help to construct a widely diversified portfolio of small, medium and large capitalization shares from a variety of industries and a variety of countries included in the MSCI Developed Markets list. The Sub-Fund may hold ancillary liquid assets for not more than 10% of its total assets.

Investment Process: The Investment Manager uses a research-driven approach (bottom-up) to select the best possible combination of quality and valuation offered in the global universe. Stocks are determined by the Investment Manager on the basis of fundamental criteria and are selected regardless of their market capitalization (small, mid, large caps), sector or geographical location. The Sub-Fund promotes environmental and/or social characteristics, as further described in the Prospectus.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Income earned by the Sub-Fund is accumulated in the net asset value of this class and not distributed.

Intended retail investor: This Sub-Fund may not be appropriate for investors who plan to withdraw their money within 5 years. This product is for professional investors with good investment knowledge, seeking long-term capital appreciation. Investors should be looking to invest for at least five years and should appreciate that their capital will be at risk and that the value of their investment and any derived income may fall as well as rise.

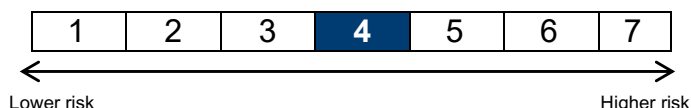

What are the risks and what could I get in return?

Risk indicator

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

A shorter holding period can cause a loss due to short-term variations in the value of securities and exchange rates. The recommended holding period reflects the time needed for the investment strategy to achieve its objectives and for the risk profile to stabilize.

You can place orders to buy or sell Sub-Fund shares at any time. Orders received on any given Luxembourg business day before 6 p.m. Luxembourg time will be processed at that day's share price.

When selling early, you will not incur any fees or penalties that are related to disinvestments within the recommended holding period. Please refer to the exit costs described in the section "What are the costs?".
